### Community Road Updates - Phase 1 & 3

An e-mail message from Marty Collier who is the Land Development Construction Manager with Stanley Martin Homes was received on the 1<sup>st</sup> of December alerting the Home Owners Association that Montgomery County Maintenance will be snow plowing the roads that have recently been paved in phases 1 & 3 of our community. Snow plowing services for Phase 2 will still be provided by Stanley Martin Homes.

As it is the Boards understanding that Montgomery County would not be plowing our communities' roads till the roads have been turned over to them, it appears this has occurred without notice to the community or any response from Montgomery County to concerns raised by the Community in regards to the paving of streets in phase 1 & 3 of the community.

The Board is following up with Montgomery County and Stanley Martin Land Development to investigate this turn of events and will provide an update to the community once more details are known.

### Trash Reminder...

Garbage, Trash. Rubbish - all nouns for material that is not wanted, usable or the remains or byproducts of something. Over this holiday season the generation of such items can be almost overwhelming. Reminder that trash must be in community approved containers covered with a lid that fits securely so to prevent foraging critters from ripping open bags and spreading refuse around the neighborhood.

Garbage is not to be left street side outside of trashcans in bags (plastic or otherwise) where last night's holiday meal becomes a buffet for the wildlife to dine on, leaving remnants of their feast to blow around the municipal creating a sanitary and unsightly mess. Wrapping paper, boxes, bottles or other recyclable materials need to conform with the Montgomery Counties regulations (break down your boxes, wrapping paper in paper recycle bags, etc.).
